Compiled teen pregnancy, teen birth and sexually transmitted disease statistics and MN Student Survey data in collaboration with the MN Department of Health Statistics and the MN Department of Education. Using these data, MOAPPP created several adolescent health reports that were posted to MOAPPP's website and disseminated widely.

MOAPPP's 19th Annual Conference brought together 360 professionals from Minnesota and beyond. Participants represented a broad range of organizations including, community based agencies (38%), public health organizations (26%), health care providers (23%), schools (16%),
